CLARIFICATION / CORRIGENDUM

Subject: Clarification regarding quoting of AMC charges

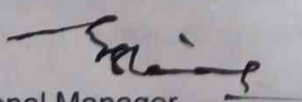
To: All Prospective Bidders / Participants

With reference to the GeM Bid and the terms and conditions contained therein, particularly **Point No. 65 regarding Annual Maintenance Contract (AMC)**, it is hereby clarified that:

1. The bidder is required to quote the **AMC charges separately** for a period of up to **four (04) years after expiry of the warranty period**, as specified in the bid document.
2. The **AMC charges shall NOT be included in the Financial Bid/price bid quoted for the supply of the equipment.**
3. The AMC amount quoted separately shall **not form part of the Financial Bid amount and shall not be considered for the financial evaluation/ranking of the bidders for the procurement of the equipment.**
4. The AMC charges are required to be quoted separately for **reference and record purposes** and shall be considered separately from the price of the equipment.
5. All bidders/participants are requested to take note of the above clarification while submitting their bids.

The Bank hereby clarifies that the AMC price is separate from the Financial Bid and shall not be included in or considered as a component of the Financial Bid for evaluation of the present procurement.

All other terms and conditions of the GeM Bid shall remain **unchanged**.
