TERMS AND CONDITIONS FOR NEW STRONG ROOM DOOR.

1. The bank receives right to accept or reject any or all the quotations without assigning any reason whatsoever.
2. The work to be completed within a period of 10 days from the date issuance of work order.
3. Class B Burglary resistance as per IS 11188 Part 2, Fire Endurance 11188 Part 3, Fire Hose Stream Reheat 11188 Part 4, IS 11188 (Part 1): 2021
4. The bill will invariably contain product serial number along with a certificate that the product complies with latest BIS standard. BIS certification by way of a metallic label on each product on each individual item with serial number will be mandatory requirement for supply of Strong Room Doors with grilled gate. Labeling of such specification is mandatory and no other self declaration will substitute this provision.
5. "BIS label - (TRTL Torch and Light Resistant) Class "B" Strong room door adhering to standard specification of "B" class currency chest i.e. improved Bankers quality strong room door. The Defender Class II strong room doors and Special Bankers quality strong room doors make confirm to the standard specifications of "B" Class Currency Chest strong room doors" is required.
6. The doors should have provision of sealing to avoid entering of water into the strong room while the door is closed and limit switch to disconnect the electrical supply to strong room once the door is closed.
7. The vendor is bound to buy back the old and non-BIS strong room door with grilled gate, if required by Bank.
8. Payment of 90% of the cost of equipment shall be made by the Branch to the Supplier on receipt of the specified goods at the site and successful installation of the equipment. Payment of balance amount shall be made by the Branch after 3 months from the date of installation provided no defects are observed during this period.
9. No advance will be paid.
10. Liquidated Damages - If the supplier fails to deliver the Goods or does not perform the Services within the time period(s) specified in the Contract, the Purchaser shall, without prejudice to its other remedies under the contract, a sum equivalent to 1% per week of the delivered price of the delayed Goods or unperformed Services for each week of delay until actual delivery or performance, up to a maximum deduction of 10% of cost of equipment. Once, the maximum is reached, the Bank may consider termination of contract and shall be entitle to terminate it.
11. Incomplete quotation shall be rejected and no further communication in this regard will be entertained. The offerer shall not make any correction/alteration on these documents. Over writing of figures is not permitted. Failure to comply with either of these conditions will
